

Works Cited Entries for Mythology Presentation (MLA 7th edition)

All Works Cited entries follow the same basic format: the author's name followed by the title of the work and publication information. Each piece of information is separated by a period. This format can get extremely complicated, so I list here in more detail the exact order for the types of sources you are using for your paper.

Note: Be sure to follow the appropriate format and arrangement **exactly**. Remember that **punctuation, indentation, and capitalization** are all important parts of your entries. Indent the second and subsequent lines in each entry five spaces or half an inch. Also, on your Works Cited page, **be sure to double space all entries** (meaning, skip every other line).

Important!

Notice the hanging indent for each entry. For all entries, **always** indent the second and subsequent lines.

Webpage source entries

For webpage sources, include the following information (if available) in the following order:

1. The name of the author.
2. The name of the article or web document (in quotation marks).
3. The name of the web site (underlined or in italics)
4. Publisher or sponsor of the site (look at the copyright if not obvious in other places); if not available, use *N.p.* Follow this with a **comma**
5. Date of publication (date, month, and year, as available); if nothing is available, use *n.d.*
6. Medium of publication (*Web*)
7. Date of access (day, month, and year)

Format (note placement of periods and commas):

AuthorLastName, AuthorFirstName MiddleInitialAnd/OrTitle. "Title of the Article." *Title of the Web Site Name*.
Sponsoring Institution, dateofpublication. Web. DateYouAccessedtheSite.

Webpage Entry Examples:

Faulkner, Andrew. "Homeric Hymns." *Oxford Bibliographies*. Oxford Bibliographies, 2014. Web. 15 Oct. 2014.

Book entries

For book sources, include the following information (if available) in the following order:

1. The name of the author
2. Title of part of the book (if applicable and in quotation marks)
3. Title of the book (underlined or in italics)
4. The name of the editor, translator, or compiler (if given)
5. Edition used.
6. Number(s) of the volume(s) used
7. Name of the series (if applicable)
8. Place of publication, name of the publisher, and date of publication
9. Page numbers (if necessary—i.e. if you are only referencing one part of the book)
10. Medium of publication consulted (*Print*)

Important!

Notice the hanging indent for each entry. For all entries, **always** indent the second and subsequent lines.

Format (note placement of periods and commas):

AuthorLastName, AuthorFirstName MiddleInitialAnd/OrTitle. "Title of Part of the Book." *Title of the Book*. Ed. FirstName LastName. #th ed. Name of Book Series. CityofPublication: Publisher, YearofPublication.

Book Entry Examples:

Use only the first significant word

Entries for Books found on the Internet

For books that are posted on the internet, follow the format for books followed above. Then, instead of the word "Print" at the end of your entry, you will provide the website information, following the format listed above. Consider the following example

Important! Notice the hanging indent for each entry. For all entries, **always** indent the second and subsequent lines.

Online Book Entry Example:

Periodical entries

For book sources, include the following information (if available) in the following order:

1. The name of the author
2. Title of the article (in quotation marks)
3. Title of the periodical (underlined or in italics); no period after this title
4. Date of Publication
5. Page numbers (if not printed on consecutive pages, write only the first page number and a plus sign)
6. Medium of publication consulted (*Print*)

Format (note placement of periods and commas):

AuthorLastName, AuthorFirstName MiddleInitialAnd/OrTitle. "Title of the Article." *Title of the Periodical*
DateofPublication: PageNumbers. Print.

Periodical Entry Examples:

Bazell, Robert. "Science and Society: Growth Industry." *New Republic* 15 Mar. 1993: 13-14. Print.

Manegold, Catherine S. "Becoming a Land of the Smoke-Free, Ban by Ban." *New York Times* 22 Mar. 1994, late ed.: A1+. Print.

Manning, Anita. "Curriculum Battles from Left and Right." *USA Today* 2 Mar. 1994: 5D. Print.

Marano, Hara Estroff. "Domestic Violence." *Psychology Today* Nov.-Dec. 1993: 48+. Print.

Remember with dates: Abbreviate the month (except May, June and July), and if the date includes a day, follow the format: **25 Feb. 2011**
